### 1. Outline of Warehouse

RPL is our 50%-owned affiliated company in Saudi Arabia engaged in on-site logistics in plants of petrochemical companies and other logistics services in the Middle East, and its new warehouse was completed on the day as stated below in Rabigh PlusTech Park, the industrial park adjoining to Rabigh Refining & Petrochemical Company (Petro Rabigh) in which many petrochemical downstream companies decided to set up their plants.

The warehouse, having both ambient-condition and temperature-controlled storage areas, can handle various types of cargoes, and additionally it is under strict security control by CCTV cameras as well as prepared for a power failure by a private power generator.
