Notice of Acquisition of Treasury Shares and Retirement of Treasury Shares

(Acquisition of treasury shares based on Articles of Incorporation pursuant to Article 165, Paragraph 2 of the Companies Act of Japan and retirement of treasury shares in accordance with Article 178 of the Act)

The Sumitomo Warehouse Co., Ltd. ("the Company") announced today that the Board of Directors resolved at the meeting held on May 13, 2022 to acquire Treasury Shares, pursuant to the provisions of Article 156 of the Companies Act, as applied pursuant to the provisions of Article 165, Paragraph 3 of the Act and also resolved to retire treasury shares in accordance with Article 178 of the Act.

1. Reason for the acquisition and retirement of treasury shares

To enhance shareholder returns and improve capital efficiency.
